Major Fields of Interest

My primary interest is in developing sociological explanations of how society shapes sexual customs, and also how it shapes gender roles, and family life. These explanations can throw light on possible resolutions of the myriad of controversial social problems related to these areas.

Summary of Research Projects

My publications both before and after my retirement are covered in the next section and they will afford the best insight into my research activities. All of my research projects are theory oriented. I have derived my theoretical explanations both inductively and deductively. Below, starting with my earliest work, are the major research foci of my exploratory efforts.:

The socio-cultural sources of American premarital sexual attitudes

The socio-cultural factors that guide the developmental path of love relationships

Similarities and differences in the cross cultural structure/function of the family institution

The socio-cultural determinants of dyadic commitment in early marriage

The socio-cultural causes of premarital contraceptive behavior

Comparison of gender roles and sexuality in Sweden and America

The socio-cultural factors predicting extramarital sexual attitudes

Similarities and differences of the socio-cultural linkages of sexuality in human societies

Traditional sexual standards and beliefs as causes of our major societal sexual problems

Analysis & evaluation of the scientific approach to human sexuality in the last 50 years with a focus on building sociological theory and applying it to our society's sexual problems.

My earliest research concerning premarital sexuality in our country was financed by three grants from the National Institute of Mental Health (1960-1964). The other research projects listed above were supported by a total of twelve other modest grants.

Teaching and Service aspects of my career are important and will be covered in other parts of this vita.

PART THREE: TEACHING EXPERIENCE

Courses Taught

I have taught many courses at both the undergraduate and graduate levels. Most of these have been in the areas of sexuality, family and gender. In these and all my courses I emphasized areas of theory and research issues, cross cultural and historical aspects, and social problems.

Chairing Graduate Students:

I supervised graduate students at both the University of Iowa from 1961 to 1969 and at the University of Minnesota from the fall of 1969 to the summer of 1996 when I retired. Thirty three of my students at these two Universities received their MA &/or Ph.D. degrees. I have also served on the committees of many other graduate students in sociology and on committees for graduate students in a number of other departments, such as Family Social Science, Geography, and History, as well as on committees evaluating graduate students at other universities here or abroad.

Supervising Undergraduate's Work:

From 1990-1996 I supervised eight undergraduate students in the completion of their senior honors theses and I served as a member of the committees of a number of other senior students. In the summer of 1991 I worked with the University Minorities Scholars' Development Program and served as a mentor for an undergraduate minority sociology student (Michele Gravenish) to help prepare her for entering graduate school. In 1992 she was awarded a three year scholarship at the University of Chicago graduate sociology program. Also, in the winter and spring of 1994 I worked with one of our senior majors (Grant Snyder) on a UROP grant research.

Teaching Evaluations and Awards:

In May of 1995 the undergraduate and graduate students in Sociology awarded me the <u>Faculty Mentoring Award</u>. This is an award given to one of the faculty whom the students believe has shown "outstanding commitment to student development."

At both the University of Iowa and the University of Minnesota I have been nominated for Distinguished Teacher Awards. Over the years, student evaluations of my courses have given me scores that consistently ranked me among the top two or three professors in the department. Also, in our department's annual faculty merit review of teaching I have consistently ranked at or close to the top.

Departmental Committees and Service

I chaired three committees in my last year at the University, 1995-96. Over the years, I have chaired virtually every committee in the department and many of them more than once. I have been elected three consecutive times as the representative of the full professors on our departmental Executive Committee and in my last year I also once again Chaired the Family, Gender and Sexuality Area Group of our Department.

I was the Director of the Family Study Center, 1969-1974. The position involved administering and applying for research grants and graduate student training grants, as well as organizing teaching programs involving faculty and graduate students predominantly in the Sociology Department.
